Trustee Prankus informed the Board that she has spoken with Ben Wilson from Kankakee County. He informed her that the price for the Village of Sammons Point to participate in the County E-Waste program would be \$1.39 per person or \$388.00 per year. The residents will be able to take their recyclables to Belson's to be disposed of. A question was asked about showing an I.D. Since the Village of Chebanse is not participating, how will they be able to verify that they are a resident of Sammons Point since Sammons Point has a Chebanse address. Trustee Prankus will look into that; we might have to give Belson's a list of our addresses. The Board would like to pass the Intergovernmental Agreement and participate in the program. Clerk Pasel will prepare the Intergovernmental Agreement for next meeting.
