

**ORDINANCE NO. 21-01**

**AN ORDINANCE AUTHORIZING THE CREATION OF A VILLAGE WEBSITE  
FOR THE VILLAGE OF SAMMONS POINT**

**WHEREAS**, The Village President and Village Trustees desire to make information concerning the Village more accessible to the public; and

**WHEREAS**, the internet is a tool widely used by municipalities throughout the State of Illinois for the purposes of providing information concerning those municipalities; and

**WHEREAS**, the Village of Sammons Point desires to establish an Internet site for the purpose of providing the public with information about the Village, including but not limited to Village meetings and documents; and

**WHEREAS**, the President and Board of Trustees of the Village of Sammons Point deem it to be in the best interests of the Village of Sammons Point and the public to establish the Village's website;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SAMMONS POINT, KANKAKEE COUNTY, ILLINOIS, THAT:**

Section 1. The foregoing recitals are hereby incorporated into this Ordinance as if fully set forth herein.

Section 2. The President of the Village of Sammons Point is hereby authorized to establish a website on behalf of the Village.

Section 3. The President of the Village of Sammons Point or the Village is hereby authorized to approve the content of the website.

Section 4. The Village website shall be maintained by Webfoot Designs, until such time as the Village determines it is in its best interests to establish a different position or designates a different person to assist with or manage the website.

Section 5. The Village authorizes the expenditures to purchase the website name and costs associated with establishment or maintenance of the website.

Section 6. This ordinance shall be in full force and effect from and after its passage and approval.
