**AN ORDINANCE AMENDING THE REGULAR MEETING SCHEDULE
FOR THE VILLAGE OF SAMMONS POINT**

WHEREAS, the Village of Sammons Point has previously adopted a regular meeting schedule for calendar year 2021; and

WHEREAS, the Village of Sammons Point desires to amend such notice to change the location of its meetings; and

WHEREAS, there is no public owned building within the Village of Sammons Point; and

WHEREAS, the Village of Sammons Point desires to conduct its meetings in a publicly owned building; and

WHEREAS, the Village of Chebanse Village Hall, located at 275 S. Oak Street Chebanse, Illinois, is not situated within the corporate limits of the Village of Sammons Point; and

WHEREAS, it is determined and found that while the Village of Chebanse Village Hall is not situated within the corporate limits of the Village of Sammons Point it is convenient and open to the public as required by the Illinois Open Meetings Act.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SAMMONS POINT, KANKAKEE COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. The Village President and Board of Trustees shall meet on the following dates for the remainder of 2021:

September 8, 2021	October 13, 2021	November 10, 2021
December 8, 2021		

All meeting shall commence at 6:00 pm and be held at the Chebanse Village Hall located at 275 S. Oak Street, Chebanse, Illinois 60922.

Section 2 all ordinances or parts of ordinance in conflict with any of the provisions of this ordinance shall be, and the same are hereby repealed.

Section 3 this ordinance and every provision thereof, shall be considered severable. In the event that any court of competent jurisdiction may find and declare any word, phrase, clause, sentence, paragraph, provision or section or part of a phrase, clause, sentence, paragraph, provision or section of this ordinance is void or unconstitutional, the remaining words, phrases, clauses, sentences, paragraphs, and provisions and parts of phrases, clauses, sentences, paragraphs, provisions and sections not ruled void or unconstitutional shall continue in full force and effect.

Section 4 this ordinance shall be effective from and after its passage and approval.


